He arbitrates mainly in Hong Kong, but also in London, Singapore and Mainland China and has published/issued over 400 arbitration awards in the past 14 years as a sole or co-arbitrator. He is the past Chairman of the Hong Kong International Arbitration Centre (HKIAC), a member of the Documentary Committee, Baltic and International Maritime Council (BIMCO), the immediate Past President of the Asia-Pacific Regional Arbitration Group (APRAG); Hong Kong Representative, ICC International Court of Arbitration. He is the author of many books and papers in international trade, shipping and arbitration related topics/matters. He is also a professor in the City University of Hong Kong and the University of Hong Kong, teaching arbitration law and practice.
