About this Talk:

This talk will examine ship lease structures, purchase arrangements, lease economics, lease termination, governing law and lease financing as an alternative to debt finance in the context of ship finance.

About speaker:

Jonathan read Mandarin at the School of Oriental and African Studies (S.O.A.S.), London University and law at City University, London (Diploma in Law) and City University of Hong Kong (Postgraduate Certificate in Laws).
